By signing this document you agree to the following, and promise to abide by same:

- Animals cannot be let off leash because they will run off.
- Animals are quite vocal and may bay loudly at times.
- Animals can take up to 30 days to adjust to a new environment and this adjustment period may include a lack of enthusiasm for play or other activities, etc.
- A house trained animal may soil a new home, and may need some extra house training as it adjusts to the new sounds and smells of a strange home.
- CSAR has limited information about the history of any animal it adopts out or places into foster care, and must rely on the accuracy of information provided by any person/shelter surrounding the animal, or from foster parents if the animal has been in foster care. For these reasons, the information you have been provided is not guaranteed.
- CSAR will be responsible for payment of all routine and emergency veterinary care. We utilize specific veterinarians and clinics within the local area. By signing this form, you agree that CSAR will NOT reimburse you or pay for any treatment or grooming expenses you may incur without advance, written pre-authorization from CSAR. You will be given telephone numbers for CSAR staff members that you may call after-hours in a true emergency situation.

**Each person who signs this application represents that she/he has never been convicted of animal neglect, cruelty, or abandonment.**

agents, representatives and assigns for any and all harm, injury or damage of any kind whatsoever caused by any animal she/he fosters from CSAR.

Each of the undersigned applicants affirms that she/he understands and agrees that CSAR is generally unaware of the history or lineage of its animals, and that representations made as to the breed of animal fostered is an estimate based on its size and appearance, and representations made by the original surrendering party, as well as evaluations made by veterinary service providers.

FOSTER'S REPRESENTATIONS AND ACKNOWLEDGEMENTS:

*Please initial by each statement below to verify each statement is accurate.*

1. I have never been convicted of any offense of animal cruelty, neglect or abandonment; and am not currently pending any such charges.
2. I have never been accused of animal cruelty, neglect, or abandonment.
3. Foster caregiver agrees to let the CSAR call for an update of the foster animal, or inspect the premises where the animal is being kept at any time to ascertain and satisfy itself that the animal is well cared for. Foster caregiver agrees to keep a collar and identification tag on the animal at all times.
4. I agree that the animal being fostered will not be sold, adopted, or given to another party by me; and that this fostered animal can only be sold, adopted, or given to another party by CSAR.
5. I represent that all the information contained in the attached foster application, signed by me, is accurate and complete; and all representations made therein by me are incorporated into this agreement by reference.
6. I agree that the foster animal will never be allowed outdoors without proper supervision.
7. Foster caregiver agrees not to alter in any way the appearance of the animal being fostered, without written permission of the CSAR. This includes declawing and ear cropping.
8. When taking the animal outdoors, foster animal will be in a completely fenced in area or securely leashed, and will continue to wear proper ID.
9. I agree that this animal is to be treated as a companion animal, not a guard or hunting animal. The animal will live inside my home, not outdoors.
10. Foster caregiver agrees to provide adequate food, water, shelter and kind treatment for the animal at all times. In addition, foster caregiver must adhere to all state and

local animal laws. Foster caregiver agrees to follow all additional written instructions from the CSAR, and agrees CSAR may update its foster policy and/or standards at anytime by written notice to foster caregiver.

11. I agree that if at any time I cannot keep the foster animal, I will return him/her to CSAR immediately. If CSAR requests return of the animal for any reason, I will do so immediately. I understand that this animal belongs to CSAR, and I have no ownership over same animal whatsoever.
12. The venue for any litigation related to enforcement of this contract shall be Azusa, California, the address of CSAR's registered agent. I agree to be liable for CSAR's legal fees, court costs, filing fees and any other costs necessary to enforce the contractual obligation herein, if CSAR sues me for enforcement or breach of this contract and I am ordered to comply with any disputed term of the contract, or I am found in breach of the contract.
13. I understand and agree that CSAR makes no guarantees about the animal's temperament and is not responsible for ANY future damages or injuries caused by the animal to personal and real property; and I agree to hold CSAR, its successors, heirs and assigns forever harmless for same damages to my or other's real and personal property, and to protect the CSAR from any claim or suit filed by anyone as a result of such an incident.
14. Foster caregiver agrees that accidental animal bites or other injuries to humans and other animals do occur, and agrees to hold harmless and indemnify, and protect the CSAR from any claim or suit filed by anyone as a result of such an incident. In addition the CSAR will not be responsible if the animal should damage or destroy property belonging to foster caregiver or should transfer any disease or internal or external parasites to other animals belonging to foster caregiver; and agrees to hold CSAR, its successors, heirs, and assigns forever harmless for same damages or injuries.
15. Foster caregiver agrees to notify the CSAR as to any behavioral or health problems of the animal. The CSAR reserves the exclusive right to determine the proper course of action to take upon such notification
16. I agree to transport this animal to/from CSAR adoption events held at various locations, and/or meetings with persons who are interested in adopting this.
17. Foster caregiver will notify the CSAR in the event any change occurs in their address, employment or telephone numbers provided herein. Foster caregiver understands and acknowledges that he/she does not have any right or authority to place foster animal in other homes, or place with other individuals, unless permission is given in writing by the CSAR.
18. I agree that all statements I have made on this form are true. If it is found that any statements I have made on this form are not true, the fostered animal can be immediately confiscated.
19. Foster caregiver is undertaking these obligations with no claim, now, or in the future, to any type of compensation or reimbursement for caring for said animal.
20. Foster caregiver agrees to notify the CSAR as to any behavioral or health problems of the animal. The CSAR reserves the exclusive right to determine the proper course of action to take upon such notification. CSAR is responsible for this animal's medical/grooming expenses, if any. I am financially liable for payment of any such

expenses if I incur them without prior authorization from CSAR. I will notify CSAR immediately of any emergency situation requiring that this animal be taken to an emergency veterinary facility. (24 hour **EMERGENCY ONLY** telephone number is (323) 842-9914.)

21. This agreement is the entire agreement of the parties, and there are no oral promises or representations made in addition to this contract and it may only be changed in a writing signed by the CSAR and the foster caregiver.
22. If any part or portion of the foster application or foster contract is found to be null and void, the remaining part and portions shall remain binding on the parties hereto, and this agreement shall be construed as if the null and void part or portion does not exist.
